#### MEETING OF INGOLDSBY PARISH COUNCIL

Minutes of the **Ingoldsby Parish Council Meeting** held in the Village Hall, Ingoldsby on Wednesday 9 December 2015.

**Public Forum:** There was one parishioner present and District Councillor Stephens.

The Chairman thanked all 24 volunteers who had turned out to help with the litter pick and village clean-up. The Chairman stated that the budget would be formally agreed upon at this meeting and welcomed any comments from parishioners.

## 1. WELCOME REMARKS BY THE CHAIRMAN (15/048)

a) The Chairman, Councillor Harrison welcomed Members to the meeting and thanked them for their attendance. Those in attendance: Councillors Eldred, Ward-Barrow and Weller.

a) Councillor Stephens advertised grant funding, noted the commencement of the Grantham southern by-pass and made reference to the proposed solar farm in Ingoldsby.
